














How it works

Once your Earned Recognition status is granted, your driver and vehicle systems monitor against a set of Key Performance Indicators (KPIs).

This doesn't mean any extra work for you, as you'll already keep track of your operational data. The ER team doesn't have direct access to your systems or data. Instead, you share a summary of this data with DVSA so we can see that you're compliant.

Your vehicles and premises won't be targeted by DVSA. As a DVSA operator you prove safety and compliance is within your business's culture. As a result, DVSA can focus on the serious and serially non-compliant. As a proven safe and trusted operator, this can help you bid for work.

Play your

Earned Recognition supports operators in maintaining safety standards on the road. By proving you have comprehensive systems and processes that promote effective transport management, you're upholding these standards. And, together, we make the roads safer for everyone.

Through the scheme, compliant operators see significant benefits. For example, you and your drivers will experience fewer costly and inconvenient roadside checks. 
