Fire hazard	Event attendees  General public	Major injuries, minor injuries, death, damage to other stands, reputational risk	H	L	<ul style="list-style-type: none"> <li>- There is a fire extinguisher on the stand to be used where necessary</li> <li>- Ensure that flammable items are not placed in direct sunlight</li> <li>- In the event of a fire ensure that persons are moved away from danger, this may be covered by event management team.</li> </ul>	L	Event attendees
Gazebo/stall present at promotions	Event attendees  General public	Major injuries, minor injuries, death, damage to vehicle, damage to other stands, reputational risk	H	L	<ul style="list-style-type: none"> <li>- Ensure that the gazebo/stall is erected according to guidelines</li> <li>- Two or more people should erect the gazebo</li> <li>- Ensure that the gazebo/stall is positioned on an even surface</li> </ul>	L	Event attendees
Electrical	Event attendees  General public	Electric shock	H	L	<ul style="list-style-type: none"> <li>- Mains powered equipment is to be taken on-site with permission of the organiser.</li> <li>- Any display lighting to hold a current electrical test. Any electrical equipment must display a current pat testing sticker.</li> <li>- Any change to electrical items must be done by a competent person.</li> </ul>	L	Event attendees
